Environmental statement

CE marking



The production of all wallpapers manufactured by Erismann & Cie. GmbH (hereinafter referred to as Erismann) must meet the appropriate, valid EN and DIN standards, in order to ensure that legal provisions are fulfilled.

All wallpapers manufactured by Erismann therefore bear, for example, an eligible CE marking in accordance with EN 15102. This serves as proof that Erismann's wallpapers fulfil the fire behaviour criteria defined by the EU.

The European Construction Products Directive also contains requirements of health and environmental protection which have not yet been provided for in DIN EN 15102. As long as there are no common European standards, national bodies are entitled to set additional requirements in this area.

VOC mark

According to the French regulation, all construction products, floor and wall coverings as well as dyes and varnishes used indoors must display an emission class label. Analysis results from an accredited test laboratory have confirmed that all of Erismann's wallpapers correspond to the limits of the lowest emission class "A+" and are labelled accordingly.

IAC Gold mark



Every European country has different limits for health and environmental requirements. Erismann sells wallpapers all over Europe and is therefore obliged to prove its adherence to all national limits for indoor emissions. This is done by submitting all wallpapers to IAC certification.

The Eurofins certification Indoor Air Comfort - **GOLD** proves that Erismann observes all relevant – as well as all voluntary – EU quality marks concerned with product emissions and indoor air quality.

The normal Indoor Air Comfort certified product level exclusively confirms that all official product emission requirements have been met.

Ral mark



In addition to fulfilling legal requirements, Erismann offers an even higher safety on a voluntary basis. The wallpapers meet the strict requirements set by Gütegemeinschaft Tapete e.V., which are documented in RAL-GZ-479. The Fraunhofer Institute regularly checks that this standard is being adhered to in the form of random sampling.

Softening agents



In addition to fulfilling the regulations concerning RAL Quality Marks, Erismann has decided not to use phthalate-containing softening agents. Since 1st January 2010, only phthalate-free softening agents have been used. The company thus fulfils the strict requirements of EU directive 2005/84/EC for toys and baby products.

In line with environmental protection and sustainability, Erismann only uses water-based colours for gravure and flexographic printing.

FSC



Moreover, Erismann only uses FSC®-certified papers and non-woven fabrics to ensure that all wallpaper rolls produced bear the FSC® logo.

Founded in 1993, the FSC® (Forst Stewardship Council) is a non-governmental, not-for-profit organisation that advocates an environmentally friendly, socially acceptable and economically sustainable use of the world's forests. The FSC® logo confirms that the wood used to manufacture the product in question is the result of responsible and sustainable forest management.
